The recipient is chosen annually from nominated applicants and receives an award of \$500. The Ruggero Piano Teacher Merit Award recognizes an individual teacher who has made a difference in students' lives, has contributed to the advancement of music in their community, and has made significant contributions to RPTA, NCMTA, and/or MTNA. An applicant may be nominated by any RPTA member. The application form along with any supporting documents must be submitted in duplicate to the current RPTA President postmarked by December 31. The following items are examples of the type of documents that should be submitted with the application.

1. Teaching/professional achievements, and number of years teaching experience
 2. Evidence of teaching excellence
 3. Accomplishments/contributions to RPTA, NCMTA, and/or MTNA
 4. Community involvement
 5. Former student or parent letter of support
 6. Professional colleague letter of support
 7. Letter of recommendation from the nominating RPTA member.

RPTA General Meeting Minutes, October 19, 2011:

Meeting called to order by Margaret Ann Smith at 0946.
Minutes of the September 2011 meeting stand approved.

New Music Issues: Allen Herther announced new music for "Adele 19 and 21" is available in easy piano, and piano/vocal. Single sheet music is also available. He is also doing a drawing at the end of the meeting for a music book. Cathy Albergo's Piano Literature book has been donated to the RPTA Library by Allen, and will be available for purchase at a reduced rate at the NCMTA Conference in Winston-Salem.

New Membership: Dee Ann Patterson introduced Elisabeth Malcom as a new member of RPTA and presented her with a certificate. Her mentor is Kerry Henry.

Courtesy: Donna Naeser gave us an update on Dee Ann Patton's father's recent aortic valve surgery. Jim Clyburn has been in the hospital recently, but is home now. Bonnie Walker's mother fell and broke her hip last Saturday. Holly Zendels' mother passed away recently. Her mother was a prominent speaker for the Holocaust and its implications. NCMTA October Conference: Diane Blanchard made announcements for the upcoming conference that will be on October 27-30. She is encouraging the collegiate members to come for the luncheon on Friday. There are a number of sessions available for instruments other than piano including strings and voice. The voice and piano master classes won't be concurrent. She read some of the bios of the people who will be presenting classes at the conference. There will be an Alexander Technique class presented by Susan Perkins. There will be an organ tour that will be very interesting. Please visit the exhibit hall and go see the exhibits and let them know that we are interested in what they have. There will be a Member's Showcase where members can show their works. We only meet once a year, and our organization needs our input at the yearly conferences.

Workshop Committee Report: Dianne Blanchard reported that 55 people registered for the Nelita True workshop for a gross income of \$3055. Expenses totaled \$2524.85. Our profit was \$530.15. Dianne gave a big thank-you to Ruggero and Hopper Piano Companies for letting us use their facilities. Big thanks was given to Christine Albro and Marlene Kelsey for providing refreshments and making it special, and to Marie Willett for the programs. Dianne expressed great appreciation to Melissa Jeffreys "who helped with everything". She received a thank-you note from Nelita True letting us know how much she enjoyed her time with us and in working with the master class students. She also loved the lighthouse book that Diane gave her as a thank-you gift.

YAA: Jeanine Skinner announced that a number of corrections have been made to the list. The most current repertoire list is on the RPTA website. The dates are March 2nd and 3rd, 2012. The Honors recital is March 11th. The time will be announced. Applications are online for you to download. Allen Herther is willing to be the new chairman next year if no one else would like this job. He will need a co-chair, if someone will volunteer. Sky Woo has the sign-up sheet for jobs, and there are jobs still available. YAA needs a continuity facilitator and a monitor coordinator. Also, if you are entering a few students, sign up for 1 job. If you are entering many students, sign up for 2 jobs or more. They need people who want to be more involved with the whole process. There is something for everybody and please sign up for jobs.

Old Business: Special thanks to Marie Willett for the lovely certificates presented to Marilyn Brown and Tome Lohr last month, and to Melissa Jeffreys for doing the financial work for the Nelita True workshop.

New Business: We have the Hopper Piano sale coming up on Saturday and Sunday, November 12 and 13, 2011. Last year, we earned greater than \$500 for the scholarship fund. Please support the sale. Margaret Anne would like volunteers to be at Hopper Piano during the sale. She will be unable to be there on the 12th. Kristen Allred announced her recent publications with Kjos Music: "Monster Jam" and "Jungle Beat". She had a handful of her books to share at the break. Sheila Page is performing a recital on November 4th locally. There is a state level science Olympiad scheduled for middle and high school students on the same date as the NCMTA Piano Festival next Feb. 18th, 2012. We will be arranging for judges soon and will need that information to help us know how many judges to hire.
